Hlubočepy - Urban development of a Prague quarter

ANNOTATION

The article documents the Baroque window paneling of the sacristies of St. Gaul at the Old Town and of Our Lady of the Angels at Hradčany. In the context of the building history of both churches the authors attempt to date the components, evaluate and describe their current state. Since the assemblage in the church at Hradčany is considered historically valuable, also other paneling components of windows and doors are included, which in some cases come from the period of the church construction.

SUMMARY

This presented text is concerned with the urban development of two parts of Hlubočepy quarter, currently incorporated within Prague 5 urban district. The attention was given to the historic centre of Hlubočepy village with the adjacent villa colony Žvahov and the hamlet Zlíchov situated to the northeast from it. Sentential processing of the theme is based on the work of groups of students of FA ČVUT and FF UK in 2013–2015, which substantiated in identification cards of individual Hlubočepy houses. These together with the results of the author's field survey and preserved maps provided the basic sources for the presented work.

Comparison with the imperial imprint of the stabile cadastre map enables an appreciation of the preserved basic urban structure of Hlubočepy. Ancient connecting lines with surrounding villages form still the main skeleton of the road network which was soon added to by side streets and low houses. There is only slight evidence of the regulation modifications probably from the onset of the 20th century, implemented non-violently to the surrounding houses or for the appearance of nearby Zlíchov, newly formed in this period of the subsiding building boom.

Systematic building activity was not developed in Hlubočepy until the formation of The Czechoslovak Republic. Ideas of the omnibus regulation plan, which was composed in the 1920s for the area of newly constituted Greater Prague, have been fulfilled here by building the Žvahov villa quarter and part of the V Bokách quarter; the idea of complete redesign of the ancient Hlubočepy centre to the contrary remained unfulfilled.

After the war Hlubočepy and Zlíchov were spared the total liquidation of the ancient buildings, which absorbed ancient centres of several Prague suburbs (Holešovice, Vysočany, Břevnov). Rather than in isolated Hlubočepy the devastation was more obvious in the close surrounding of Zlíchov, transformed by massive building of roads. Hlubočepy has not attracted any significant attention of developers until recently. Several residential projects have been realized within the village, embodying the ability of coexistence of the new and the old, as well as a blind route connected with excessive dimensions and material disharmony.
